9. **GROUND FOR CANCELLATION OF REGISTRATION.** The registered vendors are liable to be removed from the approved list of vendors, when the Firm / Company represented by their authorized representatives.

(f) If the firm is declared bankrupt or insolvent. If barred / black listed by Government Agencies / Statutory bodies, other Shipbuilding Yards, PSUs and with whom commercial transactions have been suspended for sufficient and justifiable reasons.

(g) If the firm having same Promoters / Directors / Partners as the barred / blacklisted Company / any other firm / company as at Para 'e' above for the duration for which the barring / blacklisting of sister concern persists.

(h) If the firm had fraudulently dealt with the company for pecuniary gains or had connived with any one for mutual benefit.

(i) If the firm had knowingly colluded to defeat competition with the aim of deriving undeserved profit or gain from doing business with HSL.

(j) If the firm failed to observe tendering instructions. Failed to submit an offer or a regret letter assigning reasons in response to HSL's enquiry.

(k) Any other ground which, in the opinion of the Registering Authority, the retention of the vendor's name in the list of registered vendors is not in the interest of the company.
